

**Board of Mayor and Aldermen Meeting  
Monday, April 15, 2013  
Municipal Building - Court Room**

- (1) **Call to Order:** The Board of Mayor and Aldermen met in regular session on Monday, April 15, 2013: in the Municipal Building Court Room at 7:00 p.m. Mayor John Holden presided. The meeting opened with prayer by Alderman Dennis Moody. Mayor Holden noted all were present.
- (2) **Approval of Minutes:** Minutes of the April 1, 2013 meeting were approved on a motion by Alderman Kevin Chaney, followed by a second from Alderman Bart Williams. The motion passed approving the minutes.
