

**Board of Mayor and Aldermen Meeting**  
**Monday, May 6, 2013**  
**Municipal Building - Court Room**

- (1) **Call to Order:** The Board of Mayor and Aldermen met in regular session on Monday, May 06, 2013 in the Municipal Building Court Room at 7:00 p.m. Mayor John Holden presided. The meeting opened with prayer by Alderwoman Joan Wyatt. Mayor Holden noted all were present.
- (2) **Approval of Minutes:** Minutes of the April 15, 2013 meeting were approved on a motion by Alderman Bart Williams, followed by a second from Alderwoman Jewell Horner. The motion passed approving the minutes.
- (3) **Unfinished Business:** Mayor John Holden presented the request for a beer permit from Walgreens located at 345 Hwy 51 Bypass W., Dyersburg, TN. The unfinished business comes from Walgreens prior application in April, 2013. Walgreens purchased USA Drugs at the same location in 2012, who also had a permit to sell beer. With the ownership transfer, the new owners (Walgreens) were required by to file a new application. Walgreens filed a completed application; a notice for public hearing was placed in the Dyersburg State Gazette newspaper; and the Dyersburg Police Department completed a background check affirming no reason not to grant approval. Alderman Kevin Chaney motioned for the approval of the application, followed by a second from Alderman Bob Kirk. The motioned passed by full Board vote.
