February 6, 1874
Court House

The Board of Mayor and Aldermen of Dyersburg met at Alderman Wilsons' room this 6th of February, 1874 pursuant to a call from the Mayor.

Present Mayor Neal, Aldermen Sampson, Wilson, Thurman, Deberry and White and Marshall Nichols.

On motion it was ordered that the report submitted by Jno. L. Norton Treasurer of Paducah & Memphis Rail Roa be received and spread upon the minutes, to wit:

Herewith please find plat showing location of Depot of Paducah & Memphis Rail Road at this point, said Depot is situated within half a mile of the Court House and is upon the land of B. F. Harton Esq. near the Town Cemetery and the building will be near the line of B. F. Harton and B. L. Thomas land as is more fully shown by the Plat above referred to. The Depot will be on the side of the Rail Road nearest the Court House.
