I. Establishment of a Quorum and Call to Order.

Upon hearing all discussions from the floor and from the Commission, Mr. Newbill entertained a motion on the recommendation. Mayor Holden moved to continue the

current ordinance as established. With a second by Mr. Ramm, the motion was unanimously approved.

a. Administrative Reports

Kim Morgan informed the Commission that the Board of Mayor and Alderman had approved the commission's recommendations for:

- zoning ordinance amendment, amending the municipal zoning map of Dyersburg by deleting said map and adopting a revised municipal zoning map, and
- an ordinance amending the text of the Dyersburg municipal zoning ordinance by revising the M-3 (heavy industrial).

Ms. Morgan reminded the Commission that the regional planning office will be closed by the end of June, 2011, and this meeting would be her last time to assist this Commission.
