III. New Business:

A. Discussion of Discussion of Rezoning Request on Upper Finley Road

Background Information:

Mr. Rusty Norville, Civil Engineering Solutions, presented a request involving the rezoning of two parcels of land from R-1A to R-2. The two parcels are Tax Map 087-078.00 (37.9 acres), and Tax Map 087L- B- 027.00 (approximately .82 acres).

The parcels are adjacent to each other and are located in-between R-3 zones to the west and to the east. P-B zones are located to the Southeast, Southwest, and Northwest. The R-2 zone is a more flexible residential zoning classification than the R-1, allowing semidetached (zero lot line), multi-family, and duplex dwellings. R-2 zoning can result in more dense development; however, setbacks are the same in R-2 as in R-1A. Minimum lot areas in R-2 vary with different housing styles.

Staff is of the opinion that the rezoning is in conformance with the adjacent surroundings and presents no problems, and recommended in favor of the rezoning.

Alderman Williams asked Mr. Norville what the potential housing may look like, and Mr. Norville, presented copies of potential home designs.

With no further discussion, Alderman Williams moved to approve the zoning request as presented before the Commission. The motion was seconded by Mr. Ramm, and the Commission voted unanimously to approve the motion. The rezoning request will be placed before the Mayor and Alderman Board for public notice and final approval at the Mayor and Alderman Board meeting Monday December 5, 2011.
