# Minutes for the Special Called Meeting of the City of Dyersburg Municipal-Regional Planning Commission September 24, 2015 10:00 am Municipal Courtroom

### A. Dyersburg Mall Minor Subdivision Plat

The meeting is specially called to address concerns Commissioners had from the original request at the September 10, 2015 Commission meeting.

Mr. Radford represented the following information:

## **Background**

A minor subdivision plat has been submitted on behalf of Action Dyersburg LLC to create three lots at the Dyersburg Mall location. The property is located near Mall Boulevard and State Route 78. The property can be further identified as Parcel 31.01 on Dyer County Tax Map 074. The property is zoned PB (Planned Business) District. The property does not appear to be located in a federally identified flood hazard area.

# **Analysis**

Lots 2 and 3 on the subdivision plat are landlocked. These lots are relying on two 50 foot access easements. This is compliant with the Dyersburg Municipal Subdivision Regulations.

The plans were reviewed by the City Engineer and the Dyersburg Fire Department and approved.

# Recommendation

Staff recommended approval of the plat.

After staff discussion, Mr. A.G. Helton, CEO and Broker for Action Properties, who are owners of the Dyersburg Mall, presented an overview of initial development intentions for the plat design. The brief presentation concluded with some questions from the Commissioners for Mr. Helton. All questions appeared to be of satisfaction before the Commission; therefore, a motion was made by Mayor Holden to approve the plat as presented. Commissioner Paul Newbill seconded the motion. The motion was approved unanimously by all Commissioners in attendance.
